To comply with this revenue regulation every qualified business has to implement a sales data transmission system (SDTS) to upload daily sales to the BIR portal. Data sources can be a point of sale system (POS) or a computerized accounting system (CAS) which is normally a component of an enterprise resource planning (ERP) system. SDTS will connect to the BIR EIS Middleware and its purpose is to Convert, Encrypt and Transmit sales within 3 days from the transaction date. To allow Sales Data Transmission, BIR requires businesses to be accredited in their BIR Computerized Accounting System (CAS)
